High Court Decision

- Decision yesterday 11th July.
- All legal restrictions lifted.
- Excellent News => Amalgamation will now take place.
- 1st September 2024





Key Dates

- The amalgamation will take effect on **1 September 20**24
 - Students who wish to continue their studies with Chartered Accountants Ireland will need to register with Chartered Accountants Ireland within three months of the amalgamation date
- The CPA Ireland examinations will run as planned for all levels in August 2024
 - Final sitting for Foundation and Professional exams
- During September 2024* students are required to register for their CAP1 /CAP2/
 FAE courses with Chartered Accountants Ireland
 - 16 September CAP1/CAP2 enrolment deadline
 - 30 September FAE enrolment deadline
 - 25 September CAP1 course commencement
 - 8 October CAP2 course commencement
 - 23 October FAE course commencement
- * Students who are awaiting results of August 2024 exams will be permitted late registration





Transition from CPA Foundation/Professional Level to Chartered Accountants Ireland CAP1/CAP2

- Chartered Accountants Ireland will recognise all exemptions granted by CPA Ireland and all examination passes achieved on the CPA Ireland syllabus
- Students will transition from Foundation/Professional Level to CAP1/CAP2
 - On completion of CAP1/CAP2 exams students will be eligible to sit the FAE (Core plus Elective)
- Students at the Strategic Level may elect to continue on the CPA Ireland syllabus
 - Strategic Level exams will run until August 2027

Strategic Level Transition

- Definition of Strategic
- Eligible to enrol for any strategic level exam.
- => 3 or less professional/foundation subjects remain.
- Status after August 2024 exam results.

CHOICE





Only Strategic subjects remain

- Option 1 Complete with CPA (to 2027)
 - Recommended if any strategic subjects already passed
- Option 2 Complete via Chartered FAE
 - Recommended in other situations





Strategic plus lower-level subjects remain

- Must complete CAP 1-2 equivalent subject within Chartered Accountants Ireland
- Option 1 Complete with CPA (to 2027)
 - Recommended if any strategic subjects already passed
- Option 2 Complete via Chartered FAE
 - Recommended in other situations





Training Records

- All training records submitted and accepted by CPA Ireland will be recognised by Chartered Accountants Ireland
- For CPA Ireland students who register with Chartered Accountants Ireland, there will be a 3year experience requirement. The three years' experience can be acquired before or after the Amalgamation, or a combination of both.





Training Records

- CPA Ireland students should continue to log training via MyCPA each quarter until:
 - Advised by the Institute that training is complete

OR

- Advised to switch to the CA Diary system
- Q2 2024 Training records are due by 31 July 2024





Admission to Membership

- Students who are currently "Exam Complete" and "Training Complete" have been invited to apply for membership
 - On admission to membership, they will transition to Chartered Accountants Ireland as part of the transition of all members
- Students who are "Exam Complete" and "Training Complete" after the results of the August 2024 exams are issued will be invited to apply for membership of the amalgamated Institute in Q4 2024
